


#### PROGRAMME STRUCTURE

## 課程結構

The BBA(Hons.)CGRM programme is designed for students who wish to pursue a career in corporate governance, compliance and risk management. It combines strong business and professional training with intensive exposure to communication skills, IT applications, plus language and general education subjects. Students are required to complete 125 credit units for the 4-year curriculum.




